RESTRICTIONS & REQUIREMENTS

- Vehicle parking is pre assigned on Main Street and on a first come basis.
- All registered vehicles are parked with an assigned parking space.
- Club & group parking available - must register at same time.
- All vehicles must be registered for the show and receive their registration number, parking space assignment and window card.
- Event registration fee is for all days of the event.
- Security both daytime and overnight will be provided - vehicles can stay in assigned parking space overnight.
- **No alcohol may be brought into rod run area - it's the law.**

All vehicles registered at the Downtown Hutchinson Rod Run & Classic Car Show must be licensed, insured, registered, safe and of show quality. No motorized or non-motorized contrivances which do not comply with these requirements shall be ridden or driven on the event grounds. Only recognized, single occupant handicap contrivances, motorized or non-motorized will be allowed.

- All street legal equipment (lights, etc.) is required on vehicle. (Exception: Drag-Oval-Road Race vehicles)
- Exceptions for minor items may be made at the discretion of the organizers.
- Upon inspection of pre-registered vehicle, organizers reserve the right to revoke the vehicle registration. If revoked, fee will be refunded within three weeks after event.
- Vehicles activating hydraulics and/or air bags; flames from exhaust; obscene or offensive artwork, signs stickers, etc. is prohibited.
- No roping off large sections or spaces without prior approval.
- Open exhaust system rules are strictly enforced.
- The decision of the Downtown Hutchinson Rod Run & Classic Car Show officials will be final.

GENERAL INFORMATION: The Downtown Hutchinson Rod Run & Classic Car Show will be presented in Downtown Hutchinson, Kansas on Sept. 30th, Oct. 1st and 2nd, with activities to be produced and conducted at the various locations within the city limits. All identification materials, windshield sticker and admission credentials will be issued at the event's registration office (based on registration schedule) upon presentation of your confirmation letter. No admission permitted in downtown event area for vehicles without windshield sticker in place.
